Statement Of Faith, Mission, Character, Belief and Ordinances

- 1. We believe that there is one living and true GOD, eternally existing in three persons: The Father, the Son, and the Holy Spirit, equal in power and glory; that this triune God created all, upholds all, and governs all things. (Genesis 1:1; Deuteronomy 6:4; Matthew 28:19; John 10:30; Hebrews 9:14)
- 2. We believe that the scriptures of the Old and New Testaments are the Word of God, fully inspired without error in the original manuscripts, and the infallible rule of faith and practice. The Word of God is the foundation upon which this church operates and is the basis on which this church is governed. We believe that the Word of God supersedes any earthly law that is contrary to the Holy Scriptures. We believe that the King James Version of the Bible is the most accurate translation from the original ancient text. It is from this translation that we establish our doctrine and Statement of Faith. (Isaiah 28:13; Nehemiah 8:8; John 17:17; 2 Timothy 3:16-17; Hebrews 4:12; 1 Peter 1:23-25; 2 Peter 1:21)
- 3. We believe in the person of God the Father, an Infinite, personal Spirit, perfect in holiness, wisdom, power and love; that He concerns Himself mercifully in the affairs of men; that He hears and answers prayer; and that He saves from sin and death all those who come to Him through Jesus Christ. (Deuteronomy 33:27; Psalms 90:2; Psalms 102:27; John 4:24; 1 Timothy 1:17; Titus 1:3)
- 4. We believe in the person of Jesus Christ, God's only begotten Son, conceived by the Holy Spirit. We believe in His virgin birth, sinless life, miracles and teachings, his substitutionary atoning death, bodily resurrection, ascension into heaven, perpetual intercession for His people and personal, visible return to earth. (Isaiah 7:14; Micah 5:2; Matthew 1:23; Mark 16:19; Luke 1:34-35; John 1:1-2; John 8:58; John 11:25; 1 Corinthians 15:3-4; Hebrews 1:8; 1 John 1:2; Revelation 1:8)
- 5. We believe in the person of the Holy Spirit, Who came forth from the Father and Son to convict the world of sin, righteousness, and judgment, and to regenerate, sanctify and empower for ministry all who believe in Jesus Christ; (Acts 1:8; 2 Corinthians 3:18; John 16:8-11; Romans 15:13,16; Hebrews 9:14)
- 6. We believe the Holy Spirit indwells every believer in Jesus Christ and that He is an abiding helper, teacher, and guide. (John 14:16-17, 16:8-11)
- 7. We believe in the present ministry of the Holy Spirit and in the exercise of all Biblical gifts of the Spirit. (1 Corinthians 14)
- 8. We believe that all people are sinners by nature and, therefore, are under condemnation; that God regenerates based upon faith by the Holy Spirit, those who repent of their sins and confess Jesus Christ as Lord. We do not agree that the secular government should pass laws or other ordinances that act to lead people to believe that sinful acts are not sinful and therefore not appropriate for repentance, because there are negative, eternal consequences related to unrepentant sinful actors. (Acts 8:15-17; Titus 3:5)
- 9. We believe in the universal church, the living spiritual body, of which Christ is the head and all who are born again are members. (1 Corinthians 12:12-13; Ephesians 4:15-16)
- 10. We believe that the Lord Jesus Christ committed two ordinances to the church: (a) full immersion water baptism, and (b) the Lord's Supper. (Matthew 28:19; Acts 2:38; 1 Corinthians 11:23-26)

We believe in the Second Coming of Jesus Christ which is His personal, visible return to earth and the establishment of His millennial kingdom, in the resurrection of the body, the final judgment and eternal blessing of the righteous and endless suffering of the wicked. (Matthew 16:27; Acts 1:11; Revelation 19:11-16, 20: 11-15)
- 13. We believe in what is termed "The Apostles' Creed" as embodying the fundamental facts of the Christian faith.
- 14. We believe in a literal Heaven and a literal Hell and that all those who place their faith, hope and trust in Jesus Christ will spend eternity in Heaven with the Lord, while those who reject Jesus' free gift of salvation will spend eternity separated from the Lord. (Matthew 5:3, 25:31-34; Hebrews 12:23; 1 Peter 1:4; Psalm 9:17; Matthew 5:22, 18:9; Luke 12:5)
- 15. We believe in the Pre-Tribulation Rapture of the Church where all believers will meet the Lord in the air and be taken out of this world prior to the Tribulation that will come upon the earth. (Matthew 24:29-31; Luke 21:36; Romans 1:18, 5:9; 1 Thessalonians 5:9; 2 Peter 2:7-9; Revelation 5:7-10, 7:13-14)
 - 16. We believe that, according to the Word of God, marriage is exclusively the legal union of one genetic male and one genetic female evidenced by a marriage ceremony. We also believe that legitimate biblical sexual relations are exercised solely within such a marriage. Hence, sexual activities such as, but not limited to, adultery, fornication, pre-marital sex, incest, polygamy, homosexuality, bisexuality, prostitution, pedophilia and bestiality as well as conduct such as transgenderism and cross-dressing, are all inconsistent with the teachings of the Bible and the Church. Further, lascivious behavior, the creation, viewing and/or distribution of pornography, human trafficking and efforts to alter one's physical sex or gender-related appearance are incompatible with a true biblical witness which we believe every person is called to live. (Genesis 2:24; I Corinthians 5:11; 6:9; 6:18-20; 7:1-3; 7:8-9; Romans 1:18-32)
- 17. We believe in the Genesis creation account and God as the Creator. We believe that God created man and that He created them male and female. As such He created them different so as to complement each other. God instituted monogamous marriage between male and female as the foundation of the family and the basic structure of human society. For this reason we hold homosexuality, and all other "sexual preferences" or "orientations" as unnatural, sinful, and unacceptable to God (I Corinthians 6:9-11; I Timothy 1:9-11). Statement of Responsibilities for the Student

CAMPUS LIFE

Students of Calvary Chapel Christian School (CCCS) share in the unique benefits of a Christian campus. In addition to a Christ-centered, spiritual and academic environment that seeks the best education and the richest fulfillment of potential for each individual, students are exposed to an integrated view of learning, which utilizes Scripture as the foundation for all of life. One of the unique purposes of CCCS is to prepare Christian young people for effective service for Christ in whatever career they choose.

CCCS encourages the development of the individual through emphasizing the stewardship of God-given gifts and abilities. The support of peers who share a belief in Jesus Christ is one of the advantages of attending CCCS. The faculty, staff and administrator are available for students who need their support. The extra-curricullar activities and programs offered by the school are provided as a stimulus for further growth and development. All that is done in the classroom, in extra-curricular programs, in relationships established and in knowledge gained, should reflect the mission of CCCS.

ASSUMPTIONS

- 1. That all students of CCCS profess a personal faith in Jesus Christ, and seek His Lordship in their lives.
- That all students view the Bible to be the authoritative Word of God, and therefore, are subject to its teachings and admonitions. As the Bible establishes the basic principles that guide and develop Christian character and behavior, its standards are paramount to the daily decisions made by individuals within the school.
- 3. That all students desire to grow and be more like Christ both in word and deed: that their personal commitment to Jesus Christ might mature and deepen while being a part of this school.
- 4. That all students demonstrate stewardship of their minds, time, abilities, funds and opportunities for intellectual and spiritual growth, as well as care for their bodies as the temples of the Holy Spirit.

GENERAL PRINCIPLES

There are several underlying principles, which need to be exhibited in the behavior and character of a student. By virtue of enrollment a student accepts the rights and responsibilities of attending CCCS. The CCCS student will:

- 1. Acknowledge that maturity entails both the experience of freedom and the acceptance of limits.
- 2. Demonstrate the positive attributes of new life in Christ (Rom. 12:6-21; Gal. 5:22-23; Col. 3:12-17; 2 Peter 1:5-9).
- 3. Support the rights and needs of the school, as well as adhering to all school and classroom rules, regulations and Standards of Conduct on and off campus, 365 days a year.
- 4. Assume responsibility for his/her own actions, speaking the truth and demonstrating an understanding of his/her individual role before God and to the school.
- 5. Exhibit a respectful spirit to other members of the school; both students and faculty.
- 6. Read the Parent/Student Handbook with his/her parents and agree with the rules and regulations therein.

BIBLICALLY SPEAKING

The following behavioral expectations bind all members of CCCS:

- Those acts expressly forbidden in Scripture, including premarital sexual activity, homosexuality, drunkenness, theft, profanity, occult
 practices and dishonesty are not to be practiced by members of this school.
- 2. - 3. Recognizing the Christian obligation to submit to the governing authorities (Rom. 13:1; 1 Pet. 2:12), students are expected to uphold the rules of the school, laws of the state and the nation.
- 4. While students may struggle with one or more of the listed sins, each student will seek regular fellowship, counsel, and guidance from pastors, teachers, or other appropriate spiritual leaders toward full victory and spiritual maturity.

CCCS AGREEMENTS

CCCS states certain guidelines for the conduct of faculty, staff and students. Students of CCCS are expected to refrain from the use of alcoholic beverages, tobacco, illegal drugs or abuse of either prescription or non-prescription drugs and from gambling. In addition, modesty and good taste should guide choices in dress and appearance both on campus and at school-related functions. Strict adherence to the CCCS Dress Code must be maintained. Any association or affiliation with a group or gang, which are contrary to Biblical standards, shall be strictly forbidden. CCCS does not allow social dancing at school-held or sponsored activities (any activity that involves an identifiable school group, is publicized on campus, and/or has the appearance of being school-related, whether held on or off campus). Further, students are expected to use discernment to abstain from activities that are immoral and/or morally degrading. The possession of a weapon(s) on campus or at any school-sponsored event is strictly prohibited. Male and female students are not permitted to exhibit public displays of affection toward one another. Students shall refrain from swearing and the use of any language unbecoming to a Christian, as well as acts of dishonesty such as cheating, lying or stealing. Attending CCCS is a privilege granted to those who demonstrate a spirit of harmony with the philosophy and goals of the school on and off campus, 365 days a year. CCCS reserves the right to dismiss a student who does not conform either to the stated regulations governing student conduct or to the expressed principles, policies, and expectations of the school.

Uniform Dress Standard (Upper School)

PURPOSE AND GUIDELINES

As Christians, it is our desire for students to please the Lord and be a good witness to others both in appearance and behavior. We believe there is a definite relationship between proper dress habits and grooming, proper work habits, and proper school behavior. We require students to dress modestly and attractively **without drawing undue attention** to self. Students should avoid extreme or questionable fads and fashions. Proper student dress in association with continual effort for good attitude and behavior are important elements of our wholesome Christian learning environment. Modesty is the policy here at CCCS.

The dress standard for boys and girls applies to all student activities (i.e. sporting events, school plays, graduation, etc.) both on and off campus. Students in violation may be denied entrance into the event. If a student is in dress code violation at a school event, outside of school hours, demerits will be issued to the student on their return to school. It's the responsibility of the student to adhere to these policies. School Administration reserves the right to determine that which attracts undue or excessive attention to the wearer and that which is questionable and inappropriate and is considered unacceptable. Please do not put the School Administration into this position.

Calvary Chapel Christian School (CCCS) has adopted a standard of dress policy for all students. When on campus during the regular school day and during specified school events, girls will wear the contracted uniform for girls and boys the contracted uniform for boys. Students are not allowed to wear 'street clothes' at any time while on campus unless given permission by the School Administration.

- Use of perfume and cologne is allowed in moderation. Care should be taken in the selection of scents and scents that are "overpowering" and/or "distracting" are inappropriate. The Administration reserves the right to determine what appropriate or inappropriate scent is.
- Students are to wear their hairstyles in a clean, neat and attractive manner avoiding any extreme or questionable hairstyles. No Mohawks, male students no ponytails, un kept hair styles, the tinting/painting of hair or adding any hair extensions are unacceptable. Proper grooming is expected and students are subject to the standards set by the School Administration.
- Clothing, jewelry or accessories related to a group or gang will not be permitted on campus or at any school activity. Body
 piercing, tongue rings, nose rings, etc. are not acceptable. Body tattoos that are permanent or temporary are not acceptable
 including marking any part of the body with colored pens or marsh pens.
- Students are not permitted to wear any hats, bandanas, beanies or sweatshirt hoods indoors or outdoors. This also includes
 any Christian monogrammed hats or beanies. No sunglasses are allowed in class or at any school function, on or off campus.

- Shoes and socks are to be worn by all students. Spike heels, sandals, etc. other than the specified uniform footwear are not permitted.
- Collar flaps are to be worn properly on the outside of the polo shirt and not folded up or inside the neckline. When lifting
 both arms in the air, there should be no midrib exposure. Polo shirts are to be tucked into the shorts, pants, or skorts and not
 worn on the outside. Pulling up sleeves that will expose any part of the underarms is unacceptable. No polo shirt or T-shirt
 is allowed to be pulled back and tied into a knot.
- All students clothing and lifestyle should represent a good witness to the world as well as fellow believers and that will glorify
 the Lord Jesus Christ. Clothing that represents secular musicians, alcohol, drugs, sex or other offensive/anti-biblical material
 is not acceptable.
- Cell phones and electronic devices are not allowed on campus.
- Male students are not permitted to wear any types of earrings, wallet chains, and/or stud necklaces, etc. on campus and/or school events

Males that have facial hair must keep it well trimmed. Proper grooming is expected and students are subject to the standards set by the School Administration.

Female students:

Girls skorts or skirts are not to be "folded" or "rolled over" at the waist and should fall no more than ½ " above the knee caps when lifting both arms. All appropriate undergarments are expected to be worn as part of the girl's attire and should not be visible on her outer body.

The showing of "cleavage" is not acceptable. At least one button on the uniform polo shirt must be worn closed and shirts must be correctly sized. To ensure modesty, all blouses and tops must be of appropriate size and never form fitting or clingy. Modesty is the policy here at CCCS.

Nail polish is to be modest and not draw attention to self. Modest and appropriate make-up is only allowed for female students. No heavy eyeliner, blush, foundation, etc. The School Administration reserves the right to determine what is appropriate or inappropriate make-up application.

Female students are permitted to wear jewelry in moderation. Earrings that extend below the earlobe (i.e. bangles, hoops, etc.) or plugs, tapers, etc. is not allowed. Exuberance is not acceptable or appropriate in the school environment. No holes, fishnets, lace, opaque or inappropriate tights should be worn underneath the uniform skort or skirt.

Dress Clothes/Plain Clothes

If students wear non-uniform dress/plain clothes for events, the clothing must meet the modesty standards that correspond with the school's uniform policy.

Violations of any part of the above uniform dress code will result in a student being written up as a uniform dress standard violation. Dress code standards are enforced during all school-sponsored activities/events.
